Dear Sir,

Single window – CBIC on “Simplified auto-registration of beneficiaries (IEC holders) and Normal Digital Sign-3 registration on ICEGATE for e-SANCHIT and Other benefits” Icegate provide Shipping bill, GatePass, LPO copy on your email through simplified registration, but in case you need to upload documents and access the IRN/DRN No. by your account only so you have to register Digital Signature -3 on icegate for change AD code and IGST refunds etc..

We would like to inform you that CEPC already start update RCMC on Single Window / Icegate and exchange Document Resource Number(DRN)/Image Resource Number(IRN) with registered Ice-gate Exporters/Members, CEPC request you to kindly register on ICE-gate before 31st March 2021, CEPC updating RCMCs on ICE-gate Financial year accordingly and exporters can access the RCMCs by DRN/IRN No. on Ice-gate. The registration of exporters will also enable direct access to information related to their consignments for which DG (Systems) is providing several enquiries under their login.

The importers and exporters will get intimation about the status of their consignments and PDF copies of their declarations on their registered email ids. The option of replying to the queries raised by Customs officers, including those raised during post clearance audit has also been provided under the login of the ICE holder so as to avoid the necessity of submitting the same at the service center.
