Sub.: **Council's Election – 2021 – List of Valid Voters.**

Dear Members,

You are aware that as per **Election Rules (as amended upto 24<sup>th</sup> November, 2020) of the Council** "a member from whom amount is due to Council on any account whatsoever and is not paid as on the date of issue of notification for Council's Election or a member otherwise disqualified shall not be eligible to contest, propose, second or vote in the elections of the Council". i.e. **20<sup>th</sup> July, 2021** the date of issue of Election Notification.

Accordingly, a list of 1338 eligible Members for participation in the Council's Election was released and uploaded on the web-site of the Council on 2<sup>nd</sup> August, 2021.

Thereafter the name of those Members who confirmed their payment made before 20<sup>th</sup> July, 2021 with proper details are accepted and accordingly updated list upto 26<sup>th</sup> August, 2021 with the details of 1345 Members is already uploaded on the web-site of the Council.

**It has been noticed that payment of some Members are still in suspense account of the Council in absence of intimation/ confirmation from the concerned Members.**

**Members are aware that e-voting is scheduled to start from 2<sup>nd</sup> Sept., 2021 and we require to provide the final list of Valid Voters to NSDL for sending ID and Passwords by 28<sup>th</sup> August, 2021 to enable them to send the ID and Password before 2<sup>nd</sup> Sept., 2021.**

1. **Details of Payments made before 20<sup>th</sup> July, 2021** - if their name is not in the list of Valid Voters and they made payment before 20<sup>th</sup> July, 2021.
2. **Any change/ correction in the contact details** – i.e. e-mail ID, Mobile No., Contact person on the letter head of the company duly signed and stamped.

**Any request received after 4.00 p.m. of 28<sup>th</sup> August, 2021 will not be entertained. This may be treated as final chance for any inclusion or updation/ Correction in the list of Valid Voters.**
