Council's Elections 2021 has already been notified vide Circular No. CEPC/ELE-2021/Cir. No. 1 dated 20th July, 2021. As per Election Schedule the e-voting starts from 2nd Sept., 2021 (9.30 a.m.) and will close on 9th Sept., 2021 (5.00 p.m.).

Vide circular No. CEPC/ELE-21 dated 23rd August, 2021 all eligible voters were advised to exercise your right to vote in respect of the 10 **posts of Committee of Administration from Category** —I (U.P.), 3 **posts of Committee of Administration from Category** —II (J & K), 4 **posts of Committee of Administration from Category** —III (States other than U.P. and J&K) (Please refer Para 3C III (a) of the Election Rules, already sent to all Members with the Election Notification dated 20th July, 2021).

The Counting of Votes will be held on 10^{th} Sept., 2021 from 2.00 p.m. and result will be declared accordingly on 10^{th} Sept., 2021 in the presence of Election Committee Members & Observer in Hotel Radisson MBD, Sector - 18, NOIDA.
