<u>Sub.: Request for data for revision of ceiling rates under the scheme for Remission of Duties</u>
<u>and Taxes on Exported Products (RoDTEP).</u>

Dear Members,

Members are aware that, Government has announced the benefit of the Scheme for Remission of Duties and Taxes on Exported Products (RoDTEP) to all export goods with effect from 1st January 2021 and the rates for the Carpet Sector (Chapter 57) are from 1.2% to 3.5% vide notification No. 19/2015-2020 dated 17th August 2021. As per the feedback from the Members the rates are very low and Members/industry not satisfied from the rates and ceiling cap of the RoDTEP Rates announced.

Keeping in view the feedback of the Members/ Industry, CEPC took up the issue at the highest level and undersigned flagged the issue in a meeting with Hon'ble Commerce and Industry Minister. Hon'ble Ministry has agreed to reconsider the RoDTEP Rates and asked to re-submit the required data.

Ministry of Finance welcomed the voice of Industry and requested to resubmit the proposal along with data / documentary support. In order to submit our request to the Ministry of Finance and RoDTEP Committee for reconsideration, Council require the support and cooperation of the Members in the form of submission of desired data for consideration of the RoDTEP Committee.

In this regard council has issued various circulars to member urging them for support in the form of Data / documents but no such enthusiasm seen in Members / Exporters side who willing wants to provide data. It is expected that the meeting of the RoDTEP Committee is scheduled in the mid-January, 2022 to reconsider the data.

Hence, this is last and final opportunity for the Members to kindly come forward in submitting the following documents required to the Council so that council can place strong representation before RoDTEP committee:

Data for the Period: October 2019 to March 2020

- 1. HSN Code Wise Sale October 2019 to March 2020
- 2. Shipping Bill copies for each month 1 SB copy HSN Code wise

- 3. Raw material Purchase detail head wise
- 4. Raw material Purchase detail Supplier wise, place and nos of trucks used.
- 5. Transport cost for procuring raw material for October 2019 to march 2020 along with Eway bill copy to check KM
- 6. Electricity Bill copy for October 2019 to March 2020 for each month for every unit
- 7. Electricity Ledger October 2019 to March 2020 for all units
- 8. Diesel Ledger October 2019 to March & 2/3 sample bills (used in Generator sets)
- 9. Transport cost for export of finished goods till port of exports
- 10. No of Container for outbound and port name
- 11. Composition of finished goods
- 12. Purchase from Unregistered dealers of raw material
- 13. Stamp duty charged by bank for export documents

Those members who willing to provide data may send their consent, CEPC's Team will further contact them for required data.

It may be mentioned that in the absence of submission of industry data with supporting documents all efforts taken by the council will go in vain and as a Council, we would not be able to take up the issue further and may not be held accountable for the dissatisfaction shown by the industry for the RoDTEP Rates.

Thanking you in anticipation of the cooperation of the Members in the larger interest of the Indian Handmade Carpet Industry.
