In continuation to our earlier circulars for payment of Annual Membership Subscription for the year 2022-23, we would like to inform you that council is notifying the Elections for the Post of Vice-Chairman on 2nd May 2022. Therefore, we request all our members to:

1. Kindly pay the Annual Membership subscription for the FY 2022-23. ([Click to Pay Online](#))
2. Submit CA Certificate certifying the export performance for FY 2021-22 (Mandatory).
3. The CA Certificate may be submitted on the basis of audited books or GST returns filed last year.
4. The Submitted CA certificate must contain a valid UDIN.
5. After successful payment kindly fill out the online form and update payment details ([Click to update payment Details](#)).
6. Late fees submitted by the members for 2021-22 (if any) will either be refunded or adjusted in the next year towards the membership fee.

Please note, Council has received some payments in bank accounts whose source is not traceable. If the member has made any payment to the council's account, please inform us by giving the UTR number of the same and update the payment details on the link here ([Click to update](#)).

Para 3.A.IX of the Election Rules (as amended up to 24th November 2020) of the Council provides as under:

“3.A.IX. A member from whom the amount is due to Council on any account whatsoever and is not paid as on the date of issue of notification for Council’s Election or a member otherwise disqualified shall not be eligible to contest, propose, second or vote in the elections of the Council.”

Therefore, the Members paying their Membership Subscription after 2nd May 2022 shall not be eligible to vote in the elections of the Council for Vice Chairman.

The elections for the post of the Vice-Chairman will be held by Voting by web Based remote Electronic Means. We, therefore, request our members that in case of any updates in the registered e-mail ID & Mobile No. please do inform urgently by return mail.
