Dear Members,

Council's Elections for the Office of Vice- Chairman 2022 has already been notified vide Election Notification No. CEPC/ELE-V.C.2022/Cir.No.1 dated 2nd May 2022, the Scrutiny of Nominations was held on 27th May 2022 and the last date for withdrawal of Nominations was 30th May 2022. After the date of withdrawal of Nominations, the following are the valid nomination against the vacant positions for Council's Elections 2022:

Para 3.B.XIII of the Election Rules provides as under:

"Para 3.B.XIII - Within a week of the completion of the scrutiny of nomination papers, the Secretary shall notify (Form-IV) to the members the valid nominations for each vacancy received by the Council. If the number of valid nominations for a vacancy or category received are equal to number of available seats, the candidates so nominated shall stand elected but the result shall be declared by the Returning Officer who will be provided with all details by the Secretary on the date fixed for announcement of results."

Since the number of Valid Nominations are equal to the number of vacancy(ies), no Web-based Ballot Paper shall be issued to the Members. However, the above candidate shall be declared elected on the date of declaration of results i.e., on 23rd June, 2022 as notified in, NOIDA (U.P.).
