Para 3.A.IX of the Election Rules (as amended up to 24th November 2020) of the Council provides as under: "3.A.IX. A member from whom the amount is due to Council on any account whatsoever and is not paid as on the date of issue of notification for Council's Election or a member otherwise disqualified shall not be eligible to contest, propose, second or vote in the elections of the Council." Therefore, the Members paying their Membership Subscription after 2nd May 2022 shall not be eligible to vote in the elections of the Council for Vice-Chairman.

The elections for the post of the Vice-Chairman will be held by Voting by web Based remote Electronic Means.
