 - a. Applicable for SC/ST/Women.
 - b. FOB Value of exports of or less than 50 crores in a year.
2. **Reimbursement of Airfare up to a maximum of Rs 75,000/** under the following conditions
 - a. Applicable for Members with an f.o.b value of exports below Rs 50 crores in the preceeding financial year.
 - b. Members to have completed 12 months of Membership and are regularly filing returns with CEPC.
 - c. Permissible only to the regular Director/Partner/Proprietor /Regular officer of the company in a senior managerial position (Not admissible to a foreign national)
