Carpet Export Promotion Council invites applications for participation in Domotex Intl. Trade Fair to be held at Hannover (Germany) from 11 - 14 January 2024. It is one of the world's most important and largest specialized Trade Fairs for Carpets and Floor Coverings. This fair offers an opportunity to the small-scale cottage-based member-exporters to showcase their products to potential customers from all over the world and has been providing our members a perfect platform to do business in the European Market. CEPCs Indian Pavilion will be set up in Hall 4 at Messe Ground.

## The Participation Charges are as follows:

- Built-Up Stand: Standard furniture i.e., chairs, table, waste paper basket, fascia, carpeting on the floor, electrical plug point, spotlights, and carpet clamps)
- ❖ Bare Space: Raw space exhibitors need to construct at their own & directly apply for other services i.e Electricity, Water etc.
- Corner Stand: Corner will be allotted subject to availability
- Council will allot only feasible sizes available in the Online Space Booking Form.

This year there has been an upward increase in the stand space rent offered by the organizers Deutsche Messe and due to fluctuation in the currency prices, participation charges for this year have slightly increased compared to last year. The prices have been increased marginally for small stands due to the price increase by the organizers and more for medium and larger stands due to MAI policy on subsidy per exhibitor and not per sq.mtr.

The event is being organized under the MAI Scheme of the Ministry of Commerce, Government of India.

The event under the MAI Policy entitles participating members to the following benefits.

- 1. Reimbursement of Airfare up to a maximum of Rs ₹ 90,000/ under the following conditions. (Previously reimbursement upto ₹ 75, 000)
- 2. Reimbursement of 50% freight charges support for shipment of exhibits to Micro and Small Enterprises, as defined in the MSME Act, with an upper ceiling of ₹ 50,000 /-

- 3. CEPC will be issuing visa recommendation letters, however, issuance of Timely Visa from the embassy is not CEPCs responsibility and any cancellations due to non receipt of Visa will not be eligible for refunds after 30th October, 2023.
- 4. Advance Participation Fees is refundable only in case of cancellation of the event due to unavoidable circumstances by the organizers.
- 5. Members are requested to kindly clear their outstanding dues if any as well as clear their Membership Subscription for the year 2023 24.

- 6. Council reserves the right to selection of the participants and allotment of stands and decision of the Council in this regard will be final and binding upon all members of the Council.
- 7. Members are advised to pay the fee first and then fill out the space booking form. Applications received without payment will be invalid.
