Sub.: Forthcoming Council's Elections 2024 for COA Members – Request for Payment of dues.

Dear Members,

In pursuant to the Judgement of DC (Handicrafts) dated 15th Feb., 2024 declaring the CEPC Election Result dated 10th Sept., 2021 "Null and Void" and pointing out that for CEPC Election, 2021 the COA would have completed its tenure, the Ministry of Textiles, Govt. of India directed undersigned under Articles 75 and 76(i) of Memorandum and Articles of Association of the Carpet Export Promotion Council, O/o. the Development Commissioner (Handicrafts) vide order No. 11013/120/2023-24/CEPC/ dated 15th March 2024 directed to notify the forthcoming Election on 22nd March, 2024 (Friday).

Para 3.A.IX of the Election Rules (as amended upto 24th November, 2020) of the Council provides as under:

"3.A.IX. A member from whom amount is due to Council on any account whatsoever and is not paid as on the date of issue of notification for Council's Election or a member otherwise disqualified shall not be eligible to contest, propose, second or vote in the elections of the Council."

Therefore, the Members are requested to please check from the below link whether their name is appearing in the tentative list of eligible members as per records of the Council. If Member has already paid the membership fee for the 2023-24 and their name is not appearing in Tentative Eligible Member List, they are advised to send the payment details to this office along with CA certificate (with valid UDI number) to regularize their Membership Subscription. Members are also requested to check at their end that no other payment is outstanding against their firm / company on any account what so ever.

Members who will pay their Membership Subscription after **22nd March, 2024** shall not be eligible to contest, propose, second or vote in the elections of the Council for the year 2024.
