It may be mentioned that O/o. the DC (Handicrafts) vide Judgement No. M-11013/2021/CEPC dated 15.02.2024 in the matter of Mr. Sanjay Kumar Gupta & Ors. Vs. CEPC declared the elections held on 10th Sept., 2021 as 'Null and Void" and directed CEPC to immediately conduct fresh Election for 18 COA Members of the CEPC.

In exercise of the powers conferred to the Ministry of Textiles, Govt. of India under Articles 75 and 76(I) of Memorandum and Articles of Association of the Carpet Export Promotion Council, O/o. the Development Commissioner (Handicrafts) vide order No. M-11013/120/2023-24/CEPC/229 dated 15th March, 2024 **appointed the undersigned as Returning Officer to conduct the Elections**, to fill-up the 18 COA Members by elections. Accordingly, the vacant positions for which elections are to be conducted shall be as under :

information and necessary action. Members interested in contesting the election for the vacant posts pertaining to their categories should submit their Nomination in the prescribed proforma (enclosed) within the stipulated date for filing the Nomination as indicated in the Election Schedule. Please also note that Nomination Papers are to be submitted dully filled in all respect and signed in original in CEPC's Working Office at 507, Copia Corporate Suites, Jasola, New Delhi – 110025 within the stipulated dates as specified in the Election Schedule.

**As per Election Rules (as amended upto 24th November, 2020) of the Council "a member from whom amount is due to Council on any account whatsoever and is not paid as on the date of issue of notification for Council's Election or a member otherwise disqualified shall not be eligible to contest, propose, second or vote in the elections of the Council". Accordingly, a list of eligible Members for participation in the Council's Election will be uploaded in the web-site of the Council – [www.cepc.co.in](http://www.cepc.co.in) after 22nd March, 2024 i.e. the date of issue of Election Notification.**
