The cost of a 12 sq m booth will be Rs 2,60,000 <u>before financial</u> <u>assistance.</u> After approval is received, the participation charges will be proportionately subsidized only to the eligible exhibitors participating with CEPC; otherwise, participation will be on a 100% cost recovery basis.

- 3. The participation is subject to the receipt of a sufficient number of applications or space finally made available by the organizer.
- 4. Those not submitting expressions of interest may also be considered subject to the availability of space only.
- 5. The members also need to apply for space and deposit their participation charges as and when demanded through the circulars of the respective fair that will be issued by the Council through mail and charges paid now shall be adjusted accordingly.
- 6. CEPC reserves the right for selection of participants based on the receipt of applications of respective fairs, space availability, and other terms as decided by the competent authority.
- 7. The expression of interest is refundable only if Space is not allotted / participation in the fair is canceled or withdrawn by members before allotment of space in the respective fair.
- 8. The expression of interest and participation charges are non-refundable if:-
- a. Withdrawal by the applicants after confirmation of participation by the Council.
